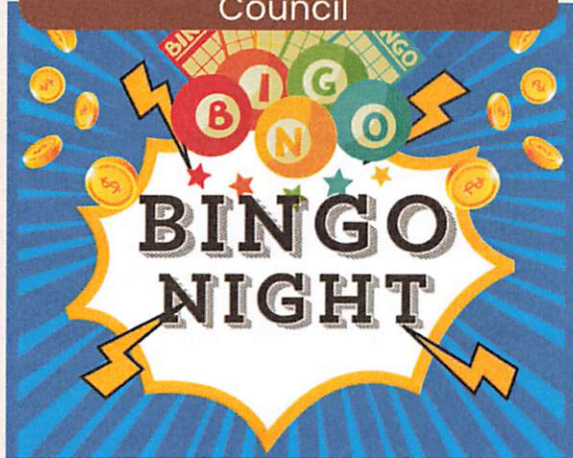

In the last Mayor's Corner, I wrote about the wildfires in Pine Valley and Bryce Canyon, little to know that we would soon be impacted by a wildfire closer to home with the Monroe Mountain fire, which became the state's biggest fire this season. Three months later, our weather is cooling, and the mountain takes on their splendid colors. Our gardening is coming to an end to an end, the corn in the field is beginning to be harvested, and we will soon put away the houses and lawnmowers. The seasons will change regularly, but one thing that will not change, is that every time I turn the corner around the White Hills on my way to Mayfield, I will always be grateful to live in this small town of Mayfield. My wife and I are grateful to have been able to raise our kids here in Mayfield. I am grateful for those who have built this town, to those who have followed and moved into Mayfield, and to those who are yet to move into Mayfield. They are looking for the same great place to raise their children, enjoy time with our extended families and help build a better community.

Last June I elected not to run for a 2nd full term as your mayor. In December I will have served for 5 years. It has been an honor to serve as your mayor. I am a strong believer that everyone should have the opportunity serve and that one should not become a lifer. There are many good people in Mayfield, who should have the opportunity to serve. I also believe that we have an obligation to step up and serve. We have had very good people serve in town council positions during this time. They have given of their expertise, resources and time to make Mayfield a better place.

I am grateful for all those who have served in staff positions in Mayfield from the office personnel to the facilities operators we have had. Each has been dedicated to providing us as citizens their best effort to improve the functions of the town. We have transitioned in most every area of the town operations. We have divided the role of Recorder/Clerk and Treasurer to comply with State Code and protect the towns funds. We have transitioned in the physical facilities, water system and roads to where we have one full time and one part time employee.

With the help of Garrick Willden, as our resident engineer, we have worked to establish a road improvement plan to resurface each of the streets over a 5-year period. Garrick has helped us put an unused spring back into production with a new pump station to lift the water to our upper tanks. This saved us from having to filter any water from our park well. We have also changed the streetlights to all LED type globes which will reduce our street light electric costs by 30%. With the help of our staff, we received funding from UDOT and a Recreation grant for 87% of the costs to install a 5' wide "Safe" sidewalk from the Order Road to 2nd North and 1st west which will connect the north side of town to the south side of town. This will create a safe path so that people will not have to walk along state highway 137 where speeds are currently set at 40 miles per hour.

During this time Mayfield Estates has completed Phase III and Phase IV of their planned development. Phase III is currently about 62% of the lots with houses already built. We received the first application for a home in Phase IV. This development has provided an opportunity for many families, both with young kids and retired couples, to move to a rural area. Mayfield will always be a growing community as more people seek to move away from the larger cities. We will prosper as we work to involve all who move to Mayfield in our activities.

We are frequently asked about our ordinances and what they allow individual citizens to do. The last complete review and update of our ordinances was in 1998. As we are getting questions we are working make some minor changes. We would need to acquire a grand funding to do a complete professional review. The ordinances established to protect the environment within the town. To some they are far too restrictive while to others they are too lenient. We will continue to work with everyone to inform them of the ordinances and why we need to comply with them.

I am grateful that Travis Good has filed for the office of Mayor. I am also very grateful for Mitzi Fuller, Jack Wilber for running for council members. Mayfield will be a great place to live if we are all involved in making it better. Thank you for all you do.
